ROBBERY

Just as this edition was going to press, thieves broke through two sets of locked gates at the Over Hospital site, broke security locks on one of the Canal Trust's excavators, 'hot wire' started it and then used it to tear off high security padlocks to gain entry to two steel shipping containers. Within these, and other securely locked containers (seven security grade padlocks were destroyed in the raid) were virtually all of the Canal Trust's hand tools, a considerable amount of reclaimed materials 'rescued' from the Hospital, a concrete mixer and many other smaller items of value. In all, including the damage caused, first estimates are that the bill could exceed £5.000.

Yes, we are insured. But that does not compensate for the many hours spent by volunteers in removing Victorian doors and other fittings from the Hospital for re-use in the new Interpretive Centre etc. - the majority of which have been stolen. As you will read elsewhere, with the permission of Swan Hill Homes we had to organise the rescue of these materials from within Hospital at very short notice as thieves started had systematically strip it bare. Is it the same people who just watched and waited for us to do the hard work of carefully removing the items before bringing in their truck to load up and speed away?

And the insurance does not recompense David Penny and Alan Lines (who turned out to support David on site once the problem

was known) who had to await the scenes of crime officer and then work late into the night to try and make what was left secure.

The Insurance will not compensate the many voluntary hours by Liz Connors and others who now have to spend time filling in the insurance claim forms and organising receipts and valuations; or the volunteers who had to rapidly find replacement tools - the robbery taking place only 48 hours prior to the February Canal Camp.

As with all contracting insurance, we do not have 'new for old' cover. Whilst some of the tools were purchased recently, many were older yet in excellent condition but will be marked down in insurance value as we will be replacing them with brand new. All very well, but a significant additional cost to the Canal Trust when added to the inevitable insurance excess.

This all happened in broad daylight in a period of less than 11/2 hours. David Penny had spent the morning working with Peter the New Deal Eyres and participants ensuring everything was ready for the Canal Camp. He left for a late lunch, securing the site behind him. By good fortune, he passed the site later in the afternoon to see the roadside gate open and the security grade padlock lying on the ground smashed to pieces. Unfortunately the thieves immediately spotted him and rapidly made themselves scarce; their vehicle being fitted with false number plates.

Editorial

What is so annoying is the fact that we had tried to everything possible to avoid trouble. Our working area is behind a lengthy fence (erected by volunteers) and the entry gate had a high grade padlock fitted; as did the main site gate. The two large shipping containers had been purchased only three weeks earlier at a cost of £2,000 (our plea in the last edition cheap containers having been unsuccessful) and were fitted with strong welded steel 'antijemmy' plates above and around the padlock. The padlocks on the containers were of such a high grade that they cost £50 each but all of this is no match for a heavy excavator bucket!

So what have we learnt? Well, there is, inevitably, a bit of stable door shutting after the horse has bolted. At a cost of hundreds of pounds all our larger dumpers and excavators are being fitted with additional security devices in an effort to minimise the risk of them being used in the future to smash their way though expensive padlocks and we will be working with Swan Hill Homes to greatly reinforce the main site entry gate.

As with everything that we do this set back will not deter us from making progress in a professional manner. At the time of writing the February Canal Camp has got under way and the additional volunteers that this brings (from all over the country) will be put to good use in many ways on the Over site. One of the most important operations will be the first pours of concrete to the foundations of the new Wharf Wall.

TIME WASTERS

Even without the robbery, the preparations for the Canal Camp have not been as straight forward as they might have been thanks to the gross incompetence of a major national supplier of Ready Mix Concrete.

The area and regional managers of the firm in question were given a conducted tour of the Over site some months ago by David Penny who took [yet another - Ed.] half days leave to show them around. Promises of sponsorship then followed - an account to be opened on highly beneficial terms. The relevant forms were completed, references supplied and we waited.

A week before the Canal Camp reminder 'faxes were sent off and ignored. Last minute 'phone calls produced a quotation for ready mix concrete that was marginally cheaper than their competitors. But when we placed the first order we were told that there was no account in place and would we fill in all the forms again...(the answer is not printable)!

With the aftermath of the robbery still taking its toll Joan Penny suddenly had a crash course in concrete specifications (Cliff Penny being too busy trying to earn enough money to pay for all of David's leave!!) and telephoned the time wasters competitors.

So thank you to Steve Rowlands of Pioneer Concrete for a more advantageous quotation and an offer of express account opening. We hope for a long and (discounted!) relationship.

Thanks to very hard work by David Penny (who spent 10 days holiday working very long hours organising all of the work at Over without any break), and our Waterway visiting Recovery Group volunteers from all over the country, the disaster of the major robbery [see page 1] was soon put behind them. Good progress was made during the week-long Canal Camp at Over in mid February. Everybody concerned determined to make it a success. And for once the weather was kind to them!

our However, trials and tribulations were not over. Following the robbery in the week prior to the Canal Camp extra special care was taken each night to disable every single engine on the excavators and large dumpers. This wasted considerable volunteer time each night and then, again, the next morning in getting everything working Everyone concerned determined that the robbers would not use our heavy plant (and that hired in) to raid our secure stores again. Following the damage to our own two secure containers the week before, one was hired in to store the valuable small tools that were on hire for the week.

On Wednesday night the thieves struck again, this time using a portable angle grinder to cut the hinges off the hired secure store. Fortunately, they must have been disturbed as the early bird WRGies arriving on site the next morning found a lot of the hire tools dumped by the main gate. However, the serious damage to the doors of the container will have to

be paid for by the Canal Trust as will an expensive timber saw and other hired items stolen from the container in this second raid.

Whilst it would not be wise to go into too much detail additional security measures are now in place [440 volts and a machine gun would be high on my list - Ed.]. A paid guard was on site for the last two nights of the Canal Camp and portable floodlighting hired in and left on all night.

The Canal Trust have always said that there are no problems only challenges. However, we simply cannot continue like this! Many hours of volunteer time and effort have already been wasted in the past ten days dealing with the aftermath of these criminals. Many pounds of hard-won funds should be taking restoration forward have been (and no doubt will continue to be) diverted into security costs - and of repairs costs replacement of stolen items.

Inspite of all this, thanks to the fantastic enthusiasm of everyone concerned, a huge amount of work was undertaken. Over the weekend London WRG carefully stripped the slate roof of the barn for reuse; our own volunteers continued muck shifting. The week long Canal Camp manufactured masses of high quality shuttering for the new wharf wall and the first foundations were poured. With a number of trained volunteers on site the opportunity was taken to make considerable progress with muck shifting - full report and, hopefully, photo's in the next edition. • CRP

We were just in time to see the Suzuki Futuristic Show on the Centre Stage with marvellous dancers and acrobats; a good start to the afternoon. 



However, new nominations to serve on the Council of Management welcomed and have to be made in writing, in a prescribed form.

Nominations must be submitted not less than 7 days nor more than 28 days prior to the AGM. The form is available from Liz Connors [see Contacts on the inside rear cover] to whom it should be returned to arrive between 30th April and 20th May.

Every Member who is entitled to vote at an AGM may appoint a proxy to vote in his/her stead. A proxy must be someone entitled to vote at the meeting. Proxy forms will be available from Liz Connors from the 30th April and must be completed, signed and returned to her at least 48 hours prior to the commencement of the AGM.



RESTOR ATION UPDATE

In the autumn issue of The Wharfinger I commented about a lack of journalists among you which I am pleased to report did not fall on stony ground. You will see that the report on Over is now being written by Nigel Bailey who lives in Gloucester and has been spending some of his weekends down there. Thank you Nigel, I hope you enjoy compiling your report for many editions to come.

Oxenhall still goes on although I must admit that has slowed down considerably over the Christmas period due to other more pressing engagements and also to various health problems among Wrinklies who are all past their prime and need to take a breather more often but should be fully recovered by the time you read this.


The first programmed of WRGies group descended on us in January from the wilds of Kent and East Sussex and once again settled accommodation at Dymock village hall where they seem to have everything they want close at hand. Their main task for the weekend was the removal of a large tree which had grown into the masonry of the lock with roots crawling everywhere to gain a hold. Some very large coping stones needed moving and were slowly pulled out with the help of their Tirfor winch attached to a large tree close by - definitely a job for specialist equipment with skilled operators and it was consequently

out by the end of the first day. More surplus roots then had to be found to make use of their winch - there are plenty of them along the side of the Canal. Another gang set to work on the old railway abutment with a Hilti breaker in an attempt to retrieve more stone to use in the lock reconstruction. Unfortunately it was so well built that it proved virtually impossible to reclaim stone without splitting it so the remains of the abutment will now be left and we shall need to find another source of good stone for rebuilding the

> lock. We rise to the challenge to find enough work for the WRGies as they work hard as well as playing hard whenever they come. We appreciate the fact that they come long distances

to help us out. We are confident that we will have plenty of rewarding work for our visitors, both at Oxenhall and Over, during the coming months!

If there is any chance of a frost we can't lay stone so the opportunity has been taken to clear vegetation between the aqueduct and House Lock. It is now possible to see the profile of the old Canal minus the water. A drainage ditch has been dug to dry out the silt, as we aim to be ready to dredge this section when we have an excavator spare. Some levels have been taken to establish heights for the Canal bed and adjacent banks. Assuming the Canal was originally 4½ft deep we have found that the towpath and opposite banks have both sunk by over a foot and will need restoring to their original height if we are to have sufficient



depth of water for navigation. Initial calculations suggest that this can be achieved by simply transferring the surplus silt in the bed to the banks but there will probably be a need for some more puddle if the banks are to be watertight. The settlement of the banks over the years has also been found at Over and was suspected at Yarkhill but I suppose is to be expected when there are tree roots and rabbits etc burrowing through!

Now over to our new contributor, Nigel Bailey -

For the last five years I have been a member of the Trust and each time I received my copy of Wharfinger I would say "I really must do something to help... sometime." When restoration began last year at Over, I really had no excuse - I live in Gloucester so it couldn't be more convenient.

Up to the autumn it was all about clearing the ground along the canal route and around The Wharf area. This was easier said than done because some of the undergrowth had been growing steadily, more dense and tangled, for more than 110 vears since the Canal closed. An Indian elephant would have come in handy for shifting some of the larger trunks. We carefully taped the mature trees which are to remain and set to work on the rest with bow saws, hooks and occasionally a chain saw. The trunk of an enormous selfseeded willow stood in the lock itself like a giant bonsai in a red brick pot. Brambles an inch thick, and ivy even thicker, had climbed the trees and made progress pretty slow. Trees that had fallen years ago complicated the task. A mature ash which would have been an attractive towpath feature was badly damaged in a storm and also had to be felled.

Most of this clearing has now been done and given the excavators a chance to work on the site of The Wharf. A good start has been made in removing the infilled soil but much more is left before we will be right down to the bed level. It is crucial that we have The Wharf site ready for the Waterway Recovery Group to move in during the February half term to commence pouring the concrete.

On weekdays Peter Eyres has been supervising youngsters from New Deal and other agencies who have worked on all sorts of tasks. Paul Brown now ably oversees our Sunday activities. Recently they have been lifting hundreds of blue bricks from a courtyard near the Mortuary building and stacking them on pallets (scrounged by Paul Brown). The bricks will be re-used to surface the top of the wall forming The Wharf. We also rescued a couple of hundred granite cobblestones which will be used as a decorative feature around the mooring rings.

With the demolition of most of the hospital buildings due to start soon. and with increasing security problems, it has become urgent to rescue anything useful from the buildings before it is damaged or stolen. We found that an enterprising local thief had been using a wheeled hospital bed as a trolley to cart materials to the footpath leading out to the main road thereby leaving the locked gates intact. David Penny's definition of "useful" is pretty wide ranging and we have been reluctant to miss anything that we can make use of in our future restoration and building work.

As soon as it was clear that the contents of the buildings were at risk, with the approval of owners Swan Hill Homes, we worked swiftly to try and beat the thieves. With help from Chris Clark and a borrowed trailer we stored away some of the materials off site at a location kindly temporarily given to us by a friend of a Member of the Canal Trust. More Victorian doors and frames, and other materials destined for the interpretive centre, have been carefully stored in our newly acquired shipping containers. [Contents stolen - see p.1 & 5 - Ed.1

Meanwhile, Dick Skeet has located a boat which we will hope to be able to base at Over to keep the weeds in check. Its currently at Taunton so, Dick, why don't you try the River Tone to Bridgwater, the Parrett to the coast, turn right up the Severn, taking the western channel at Lower Parting and then turn left into the first lock on the Hereford and Gloucester Canal. Doesn't that sound great?

Changes during the next nine months will be dramatic - and with so much to be done we still need all the help we can get. After so many months of clearing and dismantling things I'm really looking forward to the construction stage.

WANT TO GET INVOLVED ?

If ever there was a time when volunteers were required THIS IS IT! No ifs, no buts, we HAVE to complete the Over Project to the agreed specification and the agreed deadline. We would not have agreed to it if we didn't think it could be done. However, as our new Chairman says it is a "daunting task"! Or, put another way - IT IS A CHALLENGE!

No matter what your skills are, the Team need your support. As there is no public access to the Over site the only way to be part of the action (even brewing a cup of tea would be welcome!) is to telephone FIRST. Please don't hesitate until tomorrow, become part of the exciting action at Over NOW! It's not just Over, there is still plenty going on at Oxenhall. Please call:-

Committee Matters

Three Council of Management meetings are reviewed by our Editor in order that our Members and supporters are kept up to date...

OCTOBER COMMITTEE

- A new Life Family Membership from a prominent local businessman had included a £300 donation. This was warmly welcomed by the Council of Management.
- · Revised budgets, including those relating to work at Over, were agreed as were financial projections for the period March 1999 to February 2000. Following revue of agreed reimbursement mileage of expenses to an individual, the Council of Management endorsed the recommendation from Finance Committee existing arrangements continue with a further review in 6 months.
- It was reported that grant aid and sponsorship activities were not producing any positive results to date although a number of avenues were being pursued.
- Appreciation was expressed to the Chelmsford Branch of the IWA who had donated £250 towards the costs of the Acrow Bridge launch nose. This would enable the Canal Trust to erect our temporary bridge, currently spanning the Ell Brook at Oxenhall, at other sites without the need for cranes. The donation followed a talk to the Branch by Cliff Penny earlier in the year.
- A masonry saw had been purchased to assist with the ongoing restoration of House Lock

- at Oxenhall. The work was proceeding on the downstream faces of the Lock entrance walls.
- Restoration The Group reported on the first Canal Camp at Over which had taken place in late September. A considerable amount of preliminary muck shifting had been achieved by a small team largely utilising hired equipment to gain advantages of scale over the Canal Trust's own excavators and dumpers. However, a great deal more was left to be moved. A new mobile Canal Trust office was on site [formerly a mobile dental surgery Thanks to hard bargaining by David Penny, Midlands Electricity had moved a high voltage underground cable out of the way and British Telecom had moved an overhead telemetry cable; both without charge this was greatly appreciated.
- The Plant & Training Manager reported that a number of our 4 tonne dumpers were currently stripped for major repairs/ rebuilding. The Canal Trust had been offered one of the large Volvo dump trucks that had been hired for the Canal Camp at an attractive price. The CofM agreed to give consideration serious to economics of purchasing this machine. Tom Bennett was thanked for his efforts in obtaining appropriate plant for the recent Canal Camp at Over.
- It was confirmed that, following a favourable Ministerial

decision, the length of the Canal close to Stanier Way was now owned by Herefordshire Council.

- Due to work pressures, Steve Gittins had been unable to undertake Health and Safety duties relating to the work at Over. David Penny and Tom Bennett had ensured that the Canal Camp was compliant with the legislation. It was agreed that all Canal Trust restoration sites would be declared hard hat & safety footware areas as from 1st January 1999 regardless of the nature of the work in hand. Appropriate signage was to be obtained for all sites.
- The new IWA head office address was noted [see p. 24 of the last edition.]
- Our Trading Company reported two successful recent events. A donation of £25 had been received from one of the Grand Holiday Draw prize winners as a token of their appreciation for the holiday. There were queries with regard to the need to licence the bottle draw that the Canal Trust ran at some events.
- The Canal Trust were now members of the Parliamentary Waterways Group.
- It was reported that a gentlemen enquired how to make the bed of a canal watertight at the Open Day at Oxenhall, at the end of September and promptly gave a £5 donation for the information!
- Two representatives from English Heritage had been taken on a tour of the Oxenhall site by David Penny. They were impressed by our

restoration work so far on House Lock (a Listed structure).

NOVEMBER COMMITTEE

- The Chairman reported on a useful meeting with Dianne Organ, MP for the Forest of Dean, and on routine discussions with landowners in the Oxenhall area. There was ongoing liaison regarding the proposals for an arboretum at Newent. An article by the Chairman would appear in the December edition of the national publication Canal Boat & Inland Waterways.
- Following a request to exchange Membership lists with the IWA, to permit joint recruitment, the Honorary Treasurer pointed out that we were precluded from doing so by the Data Protection Act. It was agreed that we would be willing to include an IWA recruitment leaflet in The Wharfinger if the IWA reciprocated in IWA Waterways.
- It was agreed to purchase the 18 tonne Volvo dump truck following a report which indicated a very short pay-back period compared to hire costs. The hire costs already incurred in respect of the September Canal Camp at Over would be set against the purchase price.
- Grant aid was again discussed and it was agreed that there was a need for negotiating impetus to be increased and for more people to be involved in this activity.
- It was reported that the Dig Deep initiative, bringing a number

of WRG groups (from all over the country) regularly to the H&G Canal, had been approved for another year. This was welcomed.

- The restoration of the downstream approach walls to Oxenhall House Lock was now almost complete to the start of the gate recesses. The New Deal initiative at Over was slowly beginning to get results. The CofM expressed thanks to Paul Brown and Peter Eyres for their extensive voluntary supervision on this site.
- Three dumper axles had been removed for rebuilding; unfortunately they were not of a make whereby arrangements could be made to take up an offer of free refurbishment. This was regretted and, in view of the high costs

involved, the Plant & Training Manager was asked to consider this when purchasing dumpers in the future.

- Town & The Country Planning Team reported that the proposed re-development of the School of Farriery site, Hereford, had been granted permission following it being called in by the Secretary of State. This meant that the diversion route for the Canal was protected and the developer would undertake major civil engineering works as part of the development of the site including the construction of a new highway bridge and footbridge over the route of the Canal.
- The CofM thanked Tony Austin-Bailey for agreeing to take

over the vital post of Health & Safety Officer. The review of the existing Risk Assessments was already in hand.

- Preliminary arrangements for the proposed tour of the H&G Canal were discussed [details on p.31. Steve Delacourt-Smith was unable to continue to arrange the third Tuesday of the month social evenings. Ray & Barbara Moses had agreed, at short notice, to take over this important role. It was agreed that a new venue would be preferable and Ray & Barbara's suggestion of the Verzons Hotel was welcomed [see p.13].
- The Trading Company's Craft Fair, at Hereford Shirehall. had been a success but attendances were down on last year due to appalling weather. A letter and questionnaire had been sent out to Members regarding our intended 'best ever' presence at the National Waterways Festival at Worcester. Other initiatives were also in hand including regular meetings to review and plan our display.
- We would be hosting the Spring meeting of Southern Canals at a venue near the H&G Canal in April.

DECEMBER COMMITTEE

The Chairman reported receipt of the Environment Agency's consultation LEAP {Local Environment Agency Plan} for the Wye area and it was agreed that the Town & Country Planning Team would review and comment on relevant parts of this important document in liaison with the IWA.

- Work that was in hand to develop a high standard site on the Internet for the H&G Canal was welcomed. It was agreed that this needed to represent the policies and views of the Canal Trust.
- Project Approval reported to have been gained from ENTRUST for the Over site but there was no progress with grant aid from any source.
- The first of the New Deal volunteers from outside Gloucestershire had attended site at Over. It was agreed that there was a need for improved liaison between the Plant Group and the Over SPG. Arrangements for the movement of our own plant to OVER was in hand as were the necessary structural checks on the design of the new Wharf Wall.
- The IWA National Restoration Committee requested that one of their regular Committee Meetings be held close the H&G Canal with an appropriate site visit. This was warmly welcomed and would be in the Autumn of 1999.
- The Plant Group reported they had managed to upgrade one of our two 360° tracked excavators so that both were now six cylinder engined machines at no cost!
- The Town & Country Planning Team reported that the developer of the Farriery College site in Hereford had applied to delete one of the Conditions relating to the restoration of the Canal through the site. They would be dealing with the matter urgently and would be seeking no relaxation

of what had previously been agreed with regard to the route. However, they understood the reason behind the developers request.

- The Canal Trust noted proposals by the Herefordshire Council to reinforce the underside of Widemarsh Canal Bridge and requested further details. This revealed that the initial proposals would obstruct the line of the Canal and would, therefore, be the subject of an objection. Amicable negotiations were continuing.
- There had been a good response to the Questionnaire regarding our planned attendance at the National Waterways Festival, at Worcester, in August. A number of new volunteers had come forward (thank you!). Unsolicited donations had more than paid the costs of printing and mailing the questionnaire. This was greatly appreciated.
- A further CofM Strategy meeting would be convened in January.

Strategy

At the last Annual General Meeting the Council of Management undertook to review strategy. Following a number of meetings, when all potential aspects have been thoroughly debated, the CofM have determined criteria that normally be utilised to assist in the selection of future lengths of the Canal for restoration.

- The Canal Trust own the land or have a Landowner Agreement in place (mandatory).
- Lengths adjacent to, or in the vicinity of, an existing site will be preferred.
- Water resources to be available.
- Public access/trailboat access/trip boat to be feasible.
- To be economically viable with funds available and subject to cost benefit analysis.
- Community benefits and amenity value to be apparent.

The general policy is to develop significant showpiece lengths of the Canal in each county, working towards the full restoration of the Canal. However, the opportunity to work with developers or landowners on other lengths will not be ignored.

In addition to restoration priorities, it was decided that the first of the above criteria should also apply in future prior to the Canal Trust undertaking regular maintenance of a restored/partially restored section of the Canal. Strategy meetings of the full CofM are continuing in order that wider issues are addressed.


