# Editorial

#### OVER NOT OUT

After the trials and tribulations of our two robberies, reported here in the last edition of The Wharfinger, we are very pleased to say that excellent progress is being maintained at Over. This is thanks to very hard work by a small number of our own volunteers, visiting Waterway Recovery Group {WRG} volunteers from all over the country and, more recently, and students from lecturers GLOSCAT. We are indebted to all who, in the spirit of our motto, are working together to achieve what many said could not be undertaken by volunteers.

At last the Canal Basin, adjacent to The Wharf, is becoming clearly defined; many thousands of tonnes of infilled material having been excavated and transported within the site to form screening and landscaping bunds between the A40 and the new housing development. We held another highly successful week long 'muck shift' in March. However, there is still a large amount of material to be excavated! We are indebted to our own and WRG volunteers who are organising additional weekend Canal Camps in order to help us achieve our objective. Volunteers are now working on site most weekends.

The concreting for the new Wharf got off to a good start with 5 foundation pours being achieved at the first week-long Canal Camp in mid February - a length of some 38m. Another 47m of foundations to go! During a week in late April, a lecturer and students from

GLOSCAT spent three days with us working on The Wharf in very poor weather conditions. We must maintain progress with these vital concrete pours and since February we have been severely hampered by exceedingly wet weather which has led to appalling ground conditions. [Rest'n Update - p.16].

Over is not just about the restoration. challenges of however. Urgent action required following the robberies to make the site more secure. Thanks to Swan Hill Homes there is now a substantial fence along the A40 frontage, topped with evil looking (but essential) razor wire. We also have very robust gates at the main entrance. But Over is a huge site, with many other points of (illicit) entry on foot, and it was clear that more was needed to greatly reduce the risks of vet further robberies and incidents on the site. One of our long-standing Members knew of a family that he thought might be prepared to move on site so that there was a residential presence to deter our unwelcome visitors. Within week Swan Hill Homes had given permission, agreement had been drawn up and a mobile home purchased by the Canal Trust. Our thanks everyone concerned for helping us to keep a watchful eye on things.

Some of our materials are now being stored off site thanks to another Member suggesting that a relative would be prepared to make some room available. We are grateful to those concerned more detailed thanks will have to await completion of the project.

# Editorial

Apart from restoration, security, there is a huge amount of behind the scenes activity relating to Over. Plant and equipment has to be serviced, and repaired, and additional plant and equipment hired in when required. Accommodation has to be booked for our more distant volunteers sleeping on the floor of a village hall somewhere! Fuel, concrete and other materials all have to be ordered at the required time.

Discussions are ongoing with Swan Hill Homes and Tewkesbury Borough Council over the final layout for the development. We are very appreciative of the liaison that we have been afforded with the developer's Architects over points of important detail - and the fact that our suggestions are being taken seriously.

There has been an immense amount of media interest; articles nationally in Waterways World Canal Boat & and Waterways magazines, as well as the IWA's Head Bulletin and the WRG's excellent publication, Navvies. Closer to home the Gloucester Citizen carried an article which, very unusually for them, was badly researched but, thanks to quick thinking by David Penny, led to a positive piece on Central TV News and even Teletext! [see story p.24]. Meanwhile, BBC Radio Gloucester are carrying regular reports of our progress [see p.19].

Do you remember that we were so bold as to refer to 'time wasters' in the last edition - relating to a well known supplier of ready mix

concrete? What we didn't know was that a long-standing local councillor (a supporter of our voluntary endeavours for many years) used to work for a well known supplier of ready mix concrete before he retired... Thinking that the firm in question might have been one and the same he 'faxed a copy of our editorial to head office - telling them to 'pull their socks up' if it was them. Subsequently, your Editors received a 'phone call from the firm's Regional Director who promised to try and make amends we await with interest!

Then there is money. Progress at Over is generating considerable additional work for our already working Treasurer, Liz Connors. Balancing the budgets at present is a very challenging task hire equipment, maintenance, oils and fuels are not cheap. And our materials costs are significant! The Over developer's financial contribution towards our restoration costs, contained in the formal Agreement, was never intended to meet all of the costs involved. Therefore, Fundraising Officer, David Penny. hopes to utilise this money as a catalyst to obtain more significant sums; this liaison and paperwork is a considerable task.

Following our reports of the robberies, in the last edition of The Wharfinger, a number of Members and supporters sent donations and/or requests for additional Grand Holiday Draw tickets to sell. This additional support, at a time of considerable financial outlay, is greatly appreciated. Thank you.


Many thanks to all for the courtesy extended to me and also for the surprise gifts you gave me, I really didn't expect it, it was a most kind gesture, and very much appreciated.

# Committee Matters

Three Council of Management meetings are reviewed by our Editor in order that our Members and supporters are kept up to date...

#### JANUARY COMMITTEE

- Mike Potts was finding different venues for the monthly Council of Management meeting in order to be fairer to those who were regularly travelling longer distances to a single venue.
- Preliminary arrangements for the AGM (Thursday, 27th May) were agreed. It was also agreed that the formal notices in The Wharfinger should encourage new Council Members. There should be a review of procedures relating to such elections, and the conduct of the meeting, which would be strictly in accordance with our Articles of Memorandum.
- Another Canal Trust wished to use our Land Owner Agreement; it was agreed that a donation would be requested prior to reflect the considerable time and legal expense in its initial drafting. This followed the recommendation of the IWA prior to the original presentation of the document to the Southern Canals Association some years ago.
- Restoration Group reported that work at Oxenhall had been suspended over the winter months as frost was adversely affecting the mortar. However, some jungle bashing had taken place on the nontowpath side of the Canal from Ell Brook Aqueduct towards House Lock.
- There was ongoing liaison with Nigel Freeman (the new owner

- of Oxenhall Lock Cottage) including agreement to the routing of an electricity cable to the Cottage.
- The Boats Group were to investigate the offer of purchasing a 25' steel trip boat, which had been offered by a Branch of the IWA to the H&G Canal Trust.
- Our Plant & Training Manager reported on progress on re-building dumpers ready for use at Over.
- Our voluntary Health & Safety Officer, Tony Austin-Bailey, was preparing Health and Safety reports relating to restoration at Over. All volunteers would be required to have their own safety boots (which the Canal Trust would purchase at a significant discount and sell at cost) but stocks of safety helmets could be shared.
- Mike and Joyce Potts announced that they would be undertaking a number of social outings during 1999 including some in aid of the H&G Canal Trust. This was greatly appreciated.
- The Membership Secretary reported that a Corporate Member had complained that our subscription was too cheap! Bearing in mind the difficulty in attracting new Corporate Members, it was recommended that the Corporate Member in question be invited to make an additional voluntary donation.

- Cliff Penny was attempting to obtain prizes for the Grand Holiday Draw and pointed out that, with the National Waterways Festival at Worcester this year, there was added opportunity with our normal standard of good holiday prizes to raise significant funds.
- Concern had been expressed that a volunteer at Over had removed amounts of firewood for personal use on a very regular basis. It was agreed that whilst small amounts for personal use was a reasonable compromise larger amounts should only be removed subject to payment.

#### FEBRUARY COMMITTEE

- It was reported that the National Restoration Committee of the IWA would visit the Canal, after a business meeting in the morning, in October. This was warmly welcomed.
- The Regional Annual General Meeting of the IWA was to be held near Cheltenham in April. David Penny would give delegates a guided tour of the Over site and had been invited to give a short after dinner presentation, on the same day, on the restoration of the H&G Canal.
- The next Southern Canals meeting would also be in April at a venue to be arranged on the H&G Canal and would include delegates visiting Oxenhall and Over. Liz Connors agreed to arrange volunteers to prepare lunch. The Council of Management appreciated the increasing

- national interest in the Canal, largely as a result of the high profile of the work at Over, although it was emphasised that there was no intention of allowing Oxenhall to become overlooked.
- Concern was expressed at the lack of grant aid income. There were significant opportunities to utilise funds from the sale of Lock Cottage and, in particular, arising out of the Over Planning Agreement, as a catalyst for far more significant funding. There was discussion regarding employing a professional fundraiser, on a commission basis, however this was not supported. It was agreed that significant time must be found or hopefully someone with suitable experience and time to pursue this vital aspect of our work.
- Restoration Group reported that further preparatory work was ongoing at House Lock, Oxenhall, with the removal of some substantial tree roots. However, the lower levels of the railway bridge abutment were proving very difficult in respect of stone recovery. This was due to the immense strength of the mortar and it was agreed that, in any event, the lowest level should remain to act as a retaining wall to prevent scour by the Ell Brook when in flood.
- Plant and equipment was beginning to be transferred to Over, ready for regular use. Messrs Stocksigns, of Redhill, had agreed to give a very generous discount for the various health and safety signs required for Over. This was welcomed.

The forms must be completed, signed and returned to her so that they are received at least 48 hours prior to the commencement of the AGM.

We aim to allow ample time for general questions after the close of formal business. Prior notice of questions should ensure a comprehensive response and would be greatly appreciated.

NOTE REGARDING AGENDA ITEM 6. One third of the Members of the Managing Council are required to stand down each year. All those standing down (listed at 6. above) are offering themselves for re-election unless stated otherwise. New volunteers to serve on the Council of Management are welcome; as reported on p.12 of the last edition of The Wharfinger formal Nominations (on forms obtainable from the Treasurer) have to be received between 30th April and 20th May. The maximum size of the Council of Management is 18 and, unless new nominations bring the total in excess of this number, the above stated Members will be returned un-opposed. The Council of Management are also empowered to co-opt Members during the year (subject to the maximum size not being exceeded).

## ANNUAL REPORT FOR YEAR ENDED 28th FEBRUARY, 1999

This is the seventh Annual Report of The Herefordshire and Gloucestershire Canal Trust Limited [a non profit distributing Company (formed in April 1992, No. 2704407), which is a Registered Charity (1010721) and of the wholly owned Trading Company - Herefordshire and Gloucestershire Canal (Sales) Ltd [2710215]]. They replaced the Herefordshire and Gloucestershire Canal Society which was launched in 1983.

The Canal Trust is indebted to its Council of Management, and to the Trading Company Board; during the period under review [year ended 28th February 1999] those listed on page 13 have been Members:-

This has proved to be a very exciting, demanding (and expensive) year! We got off to a tremendous start with the sale of Lock Cottage at Oxenhall. The Wharfinger, throughout the year in question (year ended 28th February, 1999), was packed with photographs and reports of an exceedingly busy year, unparalleled in the history of the former Canal Society and the Canal Trust.

Last year, at the AGM, it was announced, with regret, that Bryan Heatley had resigned. We ran for some months under the leadership of our two vice Chairman. However, later in the year, Brian Fox was appointed as our new Chairman. As The Wharfinger reported, Brian Fox has been increasingly active on our behalf over a number of years. His proven voluntary efforts, with both pen and spade, made him an ideal candidate for this key post at such an important time in the life of the H&G Canal Trust.

Restoration concentrated at Oxenhall for most of the earlier part of the year. Brickwork to the tunnel portal was completed and the hidden byweir to House Lock was fully restored. This (unique?) byweir was the subject of a formal opening ceremony by local Council Officials, and Councillors. It illustrates what our volunteers can achieve (with help from visiting WRG members) with modest grant aid and a great deal of voluntary effort.

Sir John Knill Bt., Vice President, a long-standing supporter, very sadly passed away during the year.

Our Planning Team's negotiations, over a number of years, resulted in a complex legal Agreement at Over Gloucester. This key Hospital, section of the Canal is being restored as part of a deal with the landowners. Restoration activity, by our own and WRG volunteers from all over the country, is on an unprecedented scale, but there is much to do! They will soon exceed the total number of "person hours" spent on restoration on the whole Canal to date! The enthusiastic and capable organisation and management of the site by David Penny, the Project Director, has placed this project on target for a successful outcome.

Development on the Farriery College site, in Hereford, was approved following an Inquiry. The essential diversion corridor for the Canal is protected and a new highway bridge and footbridge will be built.

We don't forget the ongoing restoration work at Oxenhall House Lock. Steady progress is being made by our own "Tuesday Wrinklies". They are being regularly assisted by WRG volunteers; this project being part of the national "Dig Deep" initiative with only three or four projects supported each year.

In addition to all this, the (extensive) other work of our volunteers continues - much of it without great publicity or acknowledgement. We try not to take anything for granted and are indebted to each and everyone who has enabled us to continue to build on the solid foundations of the past.



## RESTORATION UPDATE

I reported last time that some of our Wrinklies had reported sick during colder winter months and progress at Oxenhall had slowed, but with a bit of spring sunshine on our backs, we are now continuing the rebuilding the task Unfortunately, one of our stalwarts, Dave Young, has been advised by his doctor to take on lighter duties and can no longer help with the stone laying.


Dave has been with us now for 5 years or more and was largely responsible finishing the brickwork on the tunnel portal, the spill weir and the top end of House Lock. In that time he also of his passed on some expertise to the rest of us so we shall be able to continue. We are hoping to persuade him to attend our Tuesday sessions in an advisory capacity, tell us a few jokes and, perhaps. find him some less strenuous to keep him happy - we can't afford to lose good workers.

The lock area is now looking very attractive with all the new spring growth. Primrose plants are now in full bloom on the canal bank, the cottage garden has been landscaped with new rose bushes and the cottage itself is about finished and ready to live in once more. Daffodil bulbs have been planted ready for next year - any spare bulbs you have will be welcome. A pair of moorhens has taken up residence on the canal above the lock and a pair of mallards has also been seen.

An old gentleman in his 90's was at Oxenhall last week and told us of his younger days, about 1920, when he used to play on an old boat that had been abandoned in the pool below the lock. If the remains are still there it could provide an exciting opportunity to conduct a careful excavation to discover something about the construction of the old H&G narrowboats. If we had more volunteers [subtle plea - Ed!] there is no reason why a trial excavation couldn't start now - this is definitely a job for spades and wheelbarrows - so anyone interested please give me [Brian Fox] a call.

> So much has happened since the last Over update that it is hard to know where to begin. As well as our own Canal Camp in March, we have had tremendous help with from WRG Camps in February, March and April.

The Canal Basin is now basin-shaped rather than mountain-shaped and the excavated line of the Canal now extends nearly as far as Penstocks Road, i.e. the track that leads down to the confluence of the Leadon and the Severn. [Between points 5 & 2 on the centre page map in edition 60 of The Wharfinger - Ed.] When I dropped in to see how the March week-long camp had been going I was astonished to see ten items of plant all in use simultaneously. When I looked around to see who was driving what, I found that Sally McManus (one of our Senior Citizen Members camped for the week to produce mid-morning breakfasts

and supplies of sandwiches) had mastered the art of dumper driving! Alongside her camper van was a caravan we have purchased to provide accommodation for some of our helpers from around the country. This may prove more convenient and economical in the long run than relying on village hall facilities for the smaller Canal Camps.

Excavating beyond the Basin proved interesting when we found ourselves digging through a great depth of ash, presumably produced over a period of years from the hospital's boiler and dumped in the Canal. We also dug up an entire car!

The mortuary buildings have proved very useful during the winter with part as a very efficient carpenters shop; another as a "mess room".

5 of the total of 12 concrete pours for the foundations have now been completed - so we now have almost

completed the foundation of the long arm of The Wharf. The next steps will involve our new GLOSCAT partnership with six or so students and their tutor helping us with the building of The Wharf.

Since the two break-ins security has improved enormously thanks to Swan Hill Homes' new razor wire fence and Mike and Caroline now living on site (in our newly acquired mobile home). Since taking these measures we have had no major problems although pilfering within the hospital buildings continues with persons stripping materials overnight and, recently, stealing some of our shuttering timber.


Excavations on the short arm of The Wharf have produced two interesting finds. One is the remains of the original lock gates, which help confirm the locks size and position. The other is the aqueduct, which carried the Canal over the mill race. This seems in good condition and we will have to consider carefully what to do with it now that there is no mill race to cross!

The stone barn has been demolished and all the materials stored for eventual rebuilding. Amongst the rough Cotswold stone from the walls we have found several shaped and carved stones which were clearly

recycled from an earlier structure. We are told they are from windows of 16th a manorial century building so we will try to use them as a feature when the barn rebuilt. The barn was found to contain a large number of old wheel chairs and zimmer frames, left behind

when the hospital authority decamped. We have arranged for the best of them to be repaired in the workshops at Gloucester Prison. [See p.24]

We have now ended the arrangement with New Deal who worked mid week under Peter Eyres' supervision. They have helped us on tasks such as lifting and moving railway sleepers and raising the bricks from the mortuary courtyard. The larger number of workers that we were promised never did materialise and it was mutually agreed that it was not viable to continue with just the couple of New Deal participants who were present on many of the days.



## RESTORATION UPDATE ... continued

Peter deserves a big "thank you" for harnessing the efforts of the New Deal lads over many months. This means that our weekend working is even more important than ever - our thanks to Paul Brown for coordinating this.

Brian Bailey of BBC Radio Gloucestershire visited during one of the concrete pours and recorded the first of a series of reports he will make on our progress during the year. Listen out for them on the Sunday morning "Country Matters" programme on 104.7FM or 1413MW.

Despite the rapid progress of the last three months we are currently running behind our original work schedule but the planned additional Canal Camps (and some good weather) should overcome this.

The H&G Canal Trust will be hosting WRG's annual national training week-end at Over during the last week-end in May. This provides an opportunity to be trained by some of the most experienced voluntary group leaders in the country to operate any of the plant on site. First Aid training will also be available. Why not join us? Pre-booking is essential [see p.10]

Unfortunately, as explained on p.24 of the last edition of The Wharfinger, it is not possible to pay a casual visit to the site. However, a number of guided inspection visits have taken place, including Mike Potts' tour of the Canal at the end of April. We hope to be able to announce further opportunities for such escorted visits as the work proceeds - watch this space!

## WANT TO GET INVOLVED ?

As there is no public access to the Over site the only way to be part of the action is to volunteer to assist on this exciting project - please don't just turn up - the gates could well be locked! The recent national publicity makes our successful completion all the more important; the credibility of the H&G Canal Trust is at stake.

We really can utilise any skill (and don't worry if you consider that you don't have a relevant skill, we will train you). All that we ask for is your time, and to be prepared to comply with site Health and Safety requirements at all times.

And don't forget, we've a Listed lock at Oxenhall to restore as well ...

We URGENTLY require anyone with site supervisory skills and volunteers who are regularly available to help with our restoration programme during the week, evenings and weekends.

There would be a revised planning application, as the layout agreed at Appeal was not acceptable to the developer; however, full liaison with the Canal Trust was promised (and ongoing). The Council of Management was reassured that the terms of the Planning Undertaking would preserve the line of the Canal and the Agreement was a commitment in respect of other matters.

• It was reported that three holiday prizes had been donated for the Grand Holiday Draw and that MEB (Midlands Electricity) had agreed to sponsor the cost of printing the tickets for another year. This meant that all monies raised would be available as "matching funding" thus greatly increasing the benefits from the Draw. The generosity of all concerned was greatly appreciated.

- GLOSCAT had agreed to assist with the design and construction of the Wharf Wall and this was greatly appreciated.

This was welcomed, as was the ongoing assistance of Margaret and Derek Gray.

#### MARCH COMMITTEE

- Further arrangements relating to the AGM at Ledbury on 27th May were agreed.
- John Meager, part of our fund raising team, had tendered his resignation.
- Great concern expressed at the lack of support from Council of Management, and the Membership, to David Penny who had, single handedly, managed the first WRG week long Canal Camp at Over in February. It was agreed that, in future, that when non Trust volunteers were on site every effort must be made to ensure that there were at least two Trust members available every day, present on site, to oversee progress and deal promptly with queries. It was also agreed that greater care needed to be taken in finding suitable accommodation for visiting groups with adequate kitchen sleeping areas and facilities. However, this initially exceedingly proved difficult due to existing mid week bookings of many of the village halls in close proximity to the site.
- The CofM re-affirmed Insurers requirements that all motorised plant and equipment was to be operated ONLY by persons

actually able to show a relevant and valid H&G Canal Trust or WRG Operators Certificate. The only exception being persons under formal training under the close supervision of an authorised instructor. This applied to our own Members and to visiting groups was to apply without exception.

- Improved co-ordination between the respective Special Projects Group and our Plant Group was considered essential. The Council of Management agreed that it was essential to maximise progress by utilising to the full the abilities of visiting WRG Members and that without external help our own volunteers, in isolation, could not hope to complete the work at Over within the required time scale.
- Details of additional security measures to isolate heavy plant and equipment discussed and agreed as was the purchase of a mobile home to enable residential occupation for security purposes Over. This had been agreed, at short notice, by Swan Hill Homes and the Planning Authority for which the CofM recorded their appreciation.
- The Treasurer reported that our two insurance claims in respect of the Over site will both be subject to a £500 excess. The first claim had now been submitted.
- Our Plant and Training Manager, Tom Bennett, reported that the forthcoming week-long H&G organised "muck shift" Canal Camp had sufficient trained operators, thanks to our own

Members and those from WRG, to operate shifts from 7am to 10pm. for the full week. This was warmly welcomed.

- It was reported, with regret, that Dave Young would no longer be able to undertake heavy physical work. [See p.16] masonry and scaffolding skills would, hopefully, be available to us in an advisory capacity.
- All relevant health and safety signs were now in place at Over. This was fortunate as our resident observers had reported an unannounced visit to the site by an H&SE Official.
- The Membership Secretary reported that one of our Corporate Members had sent a £100 donation

with his renewal - this was greatly appreciated. The lack of interest in Spotlight" "Corporate initiative was regretted.

- The revised location for social evenings (Verzons Country House Hotel) was proving to be highly successful. The ongoing programme of interesting speakers arranged by Ray and Barbara Moses was greatly appreciated. Potts reported that the planned tour of the H&G Canal, at the end of April, would require at least two mini buses, possibly three.
- The Planning Team, in liaison with IWA HQ., had responded to the Environment Agency (Wales) Wye Area Local Environment Agency Plan. There was ongoing correspondence with

- Good progress was being made with the creation of a 'web site' to promote the H&G Canal Trust on the Internet. #### ZIMMERED?

"Excuse me, what are you doing" was David Penny's query of the cameraman filming through the fence of Over Hospital. "I'm from Central TV - we're following up the story in the Gloucester Citizen about the scandalous waste of all of these zimmer frames and wheel chairs that were dumped in this old barn when the hospital closed."

Aware of the incorrect story in the local paper the night before (very unusually, The Citizen did not contact the Canal Trust before running it even though our sign is on the gate) David sensed that this filming was not good news! In fact it was a very critical story with the large main photograph of the many zimmer frames and wheelchairs in front of the barn inset (most unfairly) with a small photograph of the developer's signboard.

"We are about to take them all to Gloucester Prison to be refurbished for use in the third world" said David. Cameraman stops filming. Hasty chat with office on mobile 'phone!

That evening the main Central TV News carried an interview with David explaining how the contents of the barn, hidden for dense undergrowth, by would create work for prisoners and then provide much needed mobility aids in some deprived country. Just to ensure there were no further criticisms, a Regional Hospital spokesman explained that they were all of a very dated design and did not meet current safety requirements for use in this country!

Readers of Teletext that evening would have been very confused, however. Due to the very limited space available on a page they simply reported that the Canal Trust had arranged for Gloucester Prison refurbish to equipment for use overseas - with no explanation as to how a Canal Trust came into possession of all these zimmer frames and wheelchairs in the first place!

Our thanks to Tony Condor, Curator of the National Waterways Museum at Gloucester Docks, for the loan of their lorry at short notice to transport the first load to the prison.


